



High School Upgrading International Student Application Form

Chinook Learning Services welcomes individual international students to study in High School Upgrading Program to take high school credit courses.

How to Apply

1. Complete the application form.
2. Submit the application form with tuition and other fees that apply.
3. Provide a TOEFL or IELTS score.
4. Your letter of acceptance will be mailed to you or can be available immediately when payment is made in person.
5. Write the English Language Arts Placement Test.

Eligibility

International students must obtain a valid Study Permit before registering. Chinook Learning Services will issue a Letter of Acceptance upon receipt of an application form and payment of tuition fees in full. If you have a Study Permit, you are required to be a full-time student. Full time status for High School Credit is 3 courses per semester for Fall and Winter and 1 course for Summer School.

Health Insurance

All international students are required to have complete health insurance for the duration of their studies. Health insurance is extra and costs \$275 per semester (subject to change). It can be purchased through Chinook Learning Services. Students studying for a year or more are eligible for Alberta Health Insurance. Proof of health insurance must be shown at the time of registration.

Please make an appointment with Student Services by calling 403-777-7200 ext. 2433. Students will be asked to bring their Study Permit, Passport and tuition fees. You can pay by any of the following methods:

Refund and Withdrawal Policy

If you receive a Study Permit and are unable to attend due to special circumstances, your fees will be returned less a \$250 administration fee. If you are unable to get a Study Permit, your tuition fees will be refunded less a \$250 administration fee. Written notification must be received before the program begins. A full refund is given if a course is cancelled by Chinook Learning Services. Refunds are not issued once classes have begun or for non-attendance.
